(3) When called upon by the Government at any time within a period of six months from the receipt of the notice from the student as aforesaid join the state service and serve in any of the rural areas of the state for a minimum period of one year at such remuneration as may be prescribed thereof and in the event of the student not being so called upon by the Government to join the state service and serve them for the aggregate period of one year in any of the rural areas of the state and during the period which the student is required to serve under the provisions of this bond faithfully discharge the duties to him/ her by the government or his/her other superiors with utmost diligence and efficiency and shall observe the rules for the time being in force regulating the conduct of persons so serving.
